## KEY FOCUS AREAS



### 1. Water management

- Promote the delegation of water resource management to the regional or catchment level and to involve local communities

### 2. Validation and Verification

- Monitor status throughout South Africa
- Lobby for the completion of the process
- Assist government where possible

### 3. Water Use Efficiency

- Promote the implementation of water use measurement and metering
- Lobby for responsible regulation and enforcement

### 4. Transferability of water use entitlements

- Support the continued ability to permanently and temporarily transfer water use entitlements in accordance with the National Water Act

### 5. Water affordability

- Participation in Raw water tariff consultations
- Negotiate affordable tariffs
- Assist in addressing billing and debt irregularities

### 6. Deteriorating water quality and infrastructure

- Lobby for national monitoring and reporting of the quality of water resources
- Support specific projects or interventions to assist government in fulfilling its obligations

### 7. Lawful use of water

- Promote correct implementation and adherence to the National Water Act in the interests of all agricultural water users

### 8. Water Allocation Reform

- Contribute towards the development of a Transformation Charter for Water
- Investigate underutilised and non-utilised water throughout the country

### 9. Relationship with government and other stakeholders

- Cement partnerships and formal working relationships
- Cultivate productive relationships

## VOLUNTARY WATER FUND

1. Agri SA receives an annual voluntary levy from various provinces, water users' associations and irrigation boards for use in water-related matters affecting irrigation farmers
2. In performing its functions, Agri SA's Water Desk draws from the shared resources and expertise of contributors to the VWF as well as Agri SA's provincial-, commodity- and corporate affiliates
3. Through Agri SA's Water Desk, Agri SA continuously resolves issues which includes, amongst other things:
  - i. Participation in the negotiations on the annual national raw water tariff dispensation
  - ii. The derogation of existing lawful water use entitlements
  - iii. Institutional arrangements with respect to water management in South Africa, including the creation of Catchment Management Agencies (CMA's) en Local Water Management Institutions (LWMI's)
  - iv. Government's responsibilities with respect to water quality
  - v. The criteria to be applied by government when granting or refusing water use entitlements
  - vi. Participation in negotiations and providing comments in relation to proposed statutory or policy amendments with respect to water
